Dear Major General Wilson

It is with pleasure that I present the April 2017 Monthly Report – the 74th report to the Board of the Queensland Reconstruction Authority (QRA).

QRA was established under the *Queensland Reconstruction Authority Act 2011* (the Act) following the unprecedented natural disasters that struck Queensland over the summer months of 2010-11.

The Authority is charged with helping Queensland communities effectively and efficiently recover from the impacts of natural disasters through managing and coordinating the Queensland Government's program of infrastructure renewal and recovery within disaster-affected communities and being the state's lead agency responsible for disaster recovery, resilience and mitigation policy, which is delivered through working collaboratively with other agencies and key stakeholders to improve risk reduction and disaster preparedness.

Since our last report, the State has once again faced a major natural disaster in the form of Severe Tropical Cyclone Debbie which crossed the coast in the Whitsundays as a Category 4 system on 28 March 2017 bringing damaging winds and rains across the region, before unleashing flooding rains as it descended as a tropical low through southern and south-east Queensland and into New South Wales over the following days. To date, 29 local government areas in Queensland have been activated for joint Commonwealth/State Natural Disaster Relief and Recovery Arrangements (NDRRA) assistance as a result of the event and the task of cleaning up and recovering has begun. The April report tracks the event and profiles its impact on affected regions, and reports on the State's recovery planning and response efforts to date.

The April report also provides an update on progress in other recovery, resilience and mitigation activities and a snapshot of progress in the state's recovery and reconstruction from other disaster events of recent years.

In March, the State finalised and lodged its annual claim to the Commonwealth for NDRRA assistance in relation to close to \$300 million of disaster reconstruction works completed in the year to 30 June 2016. The claim was submitted to the Commonwealth ahead of the due date on 23 March 2017. The claim will now be subject to the Commonwealth's assurance activities before it can be considered acquitted and before the Commonwealth reimburses the approximate \$125 million due to the State on the claim.

Following Severe Tropical Cyclone Debbie, QRA is now managing a program of reconstruction works for 23 events from the 2015, 2016 and 2017 disaster periods that are in the delivery phase. With damage estimates starting to be prepared for this most recent event, works on the existing program are progressing. QRA has approved \$665 million of works for the earlier events and has additional submissions worth \$129 million on hand for assessment or awaiting additional information. In addition, \$405 million (58 per cent) of works in relation to the pre-Cyclone Debbie delivery program had been reported to QRA at 28 February 2017 as in progress or delivered. QRA has also commenced engagement with councils and other delivery agents to progress damage collections and identify impacts of Severe Tropical Cyclone Debbie on existing programs of work.

I commend the report to you and recommend its release to the Minister and the public pursuant to Section 41 of the Act.

## Section one: Introduction

### 1.0 Introduction

#### 1.1 Purpose

The Queensland Reconstruction Authority (QRA) was established on 21 February 2011 under the *Queensland Reconstruction Authority Act 2011* (the Act) following the extensive series of natural disasters that impacted Queensland over the summer of 2010-11.

#### QRA's mission is to reconnect, rebuild and improve Queensland communities and its economy.

QRA is charged with managing and coordinating the Government's program of infrastructure renewal and recovery within disasteraffected communities, with a focus on working with our state and local government partners to deliver best practice expenditure of public reconstruction funds.

QRA is also the state's lead agency responsible for disaster recovery, resilience and mitigation policy. In this role QRA is working collaboratively with other agencies and key stakeholders to improve risk reduction and disaster preparedness.

Initially established for a two-year period, QRA was extended a number of times as its role expanded to cover historical and continuing disaster events. In June 2015, QRA was made permanent, enabling it to continue the critical work of helping Queensland communities effectively and efficiently recover from the impacts of natural disasters.

As part of its role, QRA administers the rebuilding program for Natural Disaster Relief and Recovery Arrangements (NDRRA) activated disaster events and is responsible for the acquittal of NDRRA funding including Counter Disaster Operations, Emergent Works, Restoration of Essential Public Assets, Category C and Category D assistance to State Departments and Agencies (SDA) and Local Government Authorities (LGA). Since its establishment in February 2011, QRA has managed and coordinated the infrastructure reconstruction and recovery for 64 disaster events activated for NDRRA relief measures.

#### 1.2 Timing

The Commonwealth NDRRA Determination imposes time limits for the delivery and acquittal of works.

The Determination provides for a time limit of two financial years after a disaster to deliver reconstruction works and a further nine months after the end of the financial year in which the works were completed in order to acquit the works. NDRRA funding is formally acquitted through the annual submission of a financial statement to the Commonwealth comprising claims for financial assistance in respect of state NDRRA expenditure incurred on eligible disasters in the preceding financial year (Commonwealth Claim). Lodgement of Commonwealth Claims is required to secure reimbursement of the Commonwealth's share of eligible expenditure.

As QRA is managing a series of events that occurred across a number of financial years, QRA's program is spread across various stages in the delivery and acquittal phases as follows:



Works for 32 disaster events activated for the 2014, 2015, 2016 and 2017 event periods are currently in the delivery and/or acquittal phases.

On 23 March 2017, QRA submitted the 2015-16 NDRRA Claim to the Commonwealth for works completed to 30 June 2016. The Commonwealth has advised that it will not acquit nor pay the reimbursement due on this claim until it has completed its own assurance activities over the claim. QRA is actively engaging with the Commonwealth to facilitate its assurance activities in order to progress the acquittal and reimbursement as soon as possible.

Subject to acceptance of the 2015-16 NDRRA Claim by the Commonwealth and other than a small number of projects that received extensions of time for drought-related impacts, QRA has now finalised the close out of all works up to and including the 2014 events.

QRA is currently working with delivery agents to progress delivery of the 2015 and 2016 event programs and provide advice and assistance with damage assessments and submission preparation for the more recent 2017 events, including Severe Tropical Cyclone Debbie.


Section two: Disaster Assistance

#### 2.0 Disaster Assistance

#### 2.1 Queensland Disaster Assistance Framework

The available Queensland Disaster Assistance schemes are separated between NDRRA (jointly funded by the Commonwealth and State governments) and non-NDRRA funding schemes. The diagram below indicates the different elements of assistance available and how each element operates.





Elements of the assistance schemes are delivered by State agencies, however all NDRRA assistance sources (and elements of the non-NDRRA assistance schemes) are administered by QRA for historical and continuing disaster events in Queensland.

#### Disaster events managed by QRA

The list of the activated disaster events managed by QRA are set out in Section 2.2 and can also be found on www.disaster.qld.gov.au.

This report includes references to event periods described as follows:

- 2017 events: Activated disaster events managed by QRA occurring in the financial year ending 30 June 2017
- 2016 events: Activated disaster events managed by QRA occurring in the financial year ending 30 June 2016
- 2015 events: Activated disaster events managed by QRA which occurred in the financial year ended 30 June 2015
- 2014 events: Activated disaster events managed by QRA which occurred in the financial year ended 30 June 2014
- **2013 events:** Activated disaster events managed by QRA which occurred in the financial year ended **30 June 2013**, including Tropical Cyclone Oswald and associated rainfall and flooding (January 2013)
- 2012 events: Activated disaster events managed by QRA which occurred in the financial year ended 30 June 2012
- **2011 events:** Activated disaster events managed by QRA which occurred in the financial year ended **30 June 2011**, including Tropical Cyclone Yasi and Queensland flooding (December 2010 to February 2011).

#### 2.2 Events and relief measures managed by QRA

QRA has responsibility to administer NDRRA relief measures for historical and continuing disaster events in Queensland.

Since its establishment in February 2011, QRA has managed and coordinated the infrastructure reconstruction and recovery for 66 disaster events activated for NDRRA relief measures. Of these, 34 events are complete, having been delivered, closed out and acquitted to the Commonwealth in audited claims.

Works for 23 events from the 2015 to 2017 event periods are currently in the delivery phase<sup>1</sup> and completed works from a further 9 events from the 2014 event period are also in the acquittal phase<sup>1</sup>.

During March, two additional events were activated with Cassowary Coast Regional Council activated for the *Gulf Tropical Low, 15-24 February 2017* event and 29 councils activated to date for *Severe Tropical Cyclone Debbie and associated rainfall and flooding, 28 March - 6 April 2017* event.

The figures opposite show the LGAs activated for relief measures under NDRRA for the 2015 to 2017 event periods that are either still in delivery and/or acquittal phase.

A summary of previous events dating back to 2007 that have been managed through to acquittal by QRA is provided in Appendix B.





The NDRRA Determination imposes a time limit of two financial years after a disaster to deliver reconstruction works (delivery phase) and a further nine months to acquit completed works (acquittal phase) through lodgement of an annual claim to the Commonwealth. Following extension of time approvals, a number of projects from the 2013 and 2014 event period are still in delivery and acquittal phases.







Section three: Program Status





#### 3.1 NDRRA program status

QRA is currently assisting councils and delivery agents with the response and initial recovery activities following the impacts of Severe Tropical Cyclone Debbie and the associated rainfall and flooding with 29 councils activated for NDRRA assistance to date.

QRA is assisting, as required, with the damage assessments from Severe Tropical Cyclone Debbie in order to progress the reconstruction program into delivery as soon as possible. QRA is also monitoring and assisting delivery agents with progressing their remaining programs of work from the 2015 and 2016 events through delivery.

On 23 March 2017, QRA submitted the 2015-16 NDRRA Claim to the Commonwealth for works completed to 30 June 2016. The claim will result in an estimated \$125 million reimbursement to the State when accepted and acquitted by the Commonwealth. QRA is actively engaging with the Commonwealth to facilitate its assurance activities in order to progress the acquittal and reimbursement as soon as possible.

QRA is also continuing to participate in consultations with the Commonwealth and other jurisdictions in relation to potential natural disaster funding reforms. The Commonwealth is investigating a model to provide natural disaster recovery funding to states and territories based on upfront damage assessments and estimated reconstruction costs.

The value of the total NDRRA program of works managed by QRA since its establishment (and prior to Severe Tropical Cyclone Debbie) is estimated to be \$13.3 billion. Of this, \$12.3 billion of works from the 2009-10, 2011, 2012 and 2013 events have been finalised (delivered and acquitted) with the remaining works for the 2014, 2015, 2016 and 2017 event years in the active delivery and/or acquittal phases.

#### Active program

QRA is managing the assessment of submissions and delivery of works with an estimated value of \$702 million for the 2015, 2016 and 2017 Events<sup>1</sup> (Delivery Program) and an Acquittal Program worth \$868 million, comprising the remaining works from the 2013 to 2017 Events<sup>1</sup> that are yet to be acquitted in claims to the Commonwealth.

The damage estimates for Severe Tropical Cyclone Debbie will be incorporated into the Delivery and Acquittal Programs when available.

#### **Delivery Program status**

Since the last report, QRA's Delivery Program has progressed as follows:

- A cumulative value of \$1.0 billion in submissions have been received, an increase of \$82 million since last month
- A cumulative total of \$665 million has been approved, an increase of \$25 million since last month. Additional submissions worth \$129 million are with QRA and under investigation or awaiting additional information
- A cumulative value of \$405 million (58 per cent<sup>1</sup>) of the Delivery Program has been reported to QRA at 28 February 2017 as in progress or delivered.

The graph below shows the monthly reported expenditure and forecast monthly costs to completion at 28 February 2017 on a combined basis for the 2015 and 2016 Events.

The 2015 and 2016 Event works are due for completion by 30 June 2017 and 30 June 2018 respectively. The 2017 Events will have to 30 June 2019 to complete reconstruction works.




The 2015-16 Commonwealth Claim, representing the State's NDRRA claim for works completed in the year to 30 June 2016, was submitted to the Commonwealth ahead of deadline on 23 March 2017. The claim includes final works from the 2014 events and components of 2015 and 2016 works completed by 30 June 2016.

The claim, accompanied by an unqualified audit opinion, comprised \$292 million of State Expenditure and will result in an estimated \$125 million reimbursement when accepted and acquitted by the Commonwealth.

The Commonwealth has advised that it will not pay amounts due on this and future claims until it has completed its own assurance activities over the claim. The Commonwealth has commenced its assurance review of the 2015-16 Claim but has not committed to any timeframe for undertaking the assurance activities.

QRA is actively engaging with the Commonwealth to progress the review in order to expedite the acquittal of, and payment due on the claim.

The following graph shows the historical and projected acquittal profile for Queensland as per Commonwealth Claims submitted for the 2001-02 to 2015-16 financial years and Commonwealth Claims preliminarily expected to be submitted for 2016-17 to 2017-18 in order to finalise acquittal of the \$868 million remaining in the Acquittal Program.





#### TMR Check.Plan.Go with QLDTraffic

Queenslanders now have access to enhanced traffic and travel information – including on road closures due to natural disaster events like Severe Tropical Cylcone Debbie – with the launch of the new QLD*Traffic* website, mobile application and regional Twitter handles.

Transport and Main Roads conducted customer research asking everyday Queensland road users about their travel habits and what information would help them get where they needed more easily.

The result? Check.Plan.Go with QLDTraffic.

The new QLDTraffic website enables users to:

- filter traffic information more easily by simply selecting an event type such as flooding, roadworks or hazard
- view the latest images from available traffic camera feeds using images of the road network
- view alerts and warning messages about incidents impacting a particular road, area or region.

The QLD*Traffic* mobile app was developed in response to continuing growth in smartphone access to the QLD*Traffic* website and its predecessor, 131940.qld.gov.au.

App users can save their favourite route and receive notifications for relevant traffic events, see how long it will take to drive from A to B, view and select alternative routes and view traffic camera feeds to see what's happening on the roads.

The initiative also included introducing a new back-end system to improve data accuracy, provide a more intuitive, efficient interface for operators and enable operators to lend a hand to other districts during critical events such as natural disasters.

### TMR Progress update - Burnett River Bridge replacement Works to replace the Burnett River Bridge between Monto and Eidsvold are continuing, with laying of the deck units completed in February. The bridge, previously located on Monto–Mount Perry Road about 6km southeast of the Burnett Highway, was washed away by floodwaters associated with Severe Tropical Cyclone Marcia in February 2015. Eligible works will be funded under the NDRRA with additional complementary state funding allocated to ensure value for the community by improving flood immunity. To improve safety for motorists, the road and new bridge have also been realigned to reduce the curvature of the bridge approaches and improve visibility for motorists. Construction activities at the project site commenced in September 2016. A temporary river crossing was constructed to maintain access across the Burnett River until the bridge is opened to traffic. Following completion of the bridge sub-structures, the precast concrete deck units have been installed in February and works are continuing on the road approaches. The Burnett River Bridge replacement is scheduled for completion in the first half of 2017, within the NDRRA funding timeframe. Burnett River Bridge – installation of bridge decking

#### 4.1 Communicating progress

#### Media analysis

There has been a total of 1,449 media items in March 2017 (511 print – 35%, 373 TV – 26%, 498 radio – 34%, 67 online – 4%), which reached a cumulative audience of approximately 91.9 million people.


On 28 March 2017, **Premier Annastacia Palaszczuk** appointed former QRA Chief of Operations and Planning, **Brigadier Christopher Field AM CSC**, as the state's Disaster Recovery Coordinator for Tropical Cyclone Debbie. Brigadier Field's planning team, comprising QRA, Australian Defence Force and Queensland Fire and Emergency Service members, is ensuring there is a comprehensive, community focussed and local government-led recovery, supported and coordinated via a whole-of-government approach.

On 31 March 2017, **Deputy Premier Jackie Trad** joined Brigadier Field in North Queensland to inspect damage inflicted on the region by Tropical Cyclone Debbie.

#### Communications

QRA keeps its stakeholders and the community informed and ensures access to the latest information through QRA's website, phone hotline and management of correspondence.

QRA's website is regularly updated, including information about progress on current recovery efforts. There has been a large number of visits to the website since it was launched on 18 February 2011. At 31 March 2017, total website visits amounted to 518,506. *(See Figure 5.1.1)* In February, QRA received an additional 143 calls to our dedicated hotline and managed 268 pieces of written correspondence (*See Figure 5.1.2*)
